VIEWPOINT REGULATIONS CONCERNING COVID-19

(as of April 30, 2020)

- Due to the COVID-19 situation all organized Clubhouse activities and remaining hikes by the hiking group are canceled until further notice.
- Based on careful review of the current Arizona Lockdown guidelines it has become apparent we must shut down the Viewpoint pool and spa.
- We are also closing the clubhouse as we cannot provide any guarantees of occupants following social distancing when the facility might be used.

The Governor is expected to provide additional guidance around May 15. Until then, all of the Viewpoint facilities should be considered off-limits to all association members.

When new guidelines are released, we will review and respond accordingly.

VIEWPOINT HOA POOL AND SPA

Governor Ducey issued an Executive Order on April 4, 2020 that established the Stay At Home and Social Distancing requirements for Arizona. The Order listed allowable outdoor exercise activities: walking, hiking, running, biking or golfing, but only if appropriate physical distancing practices are used. The Governor's subsequent Executive Order on April 29, 2020 did not amend the April 4th order limiting outdoor

exercise activities and, especially the use of communal swimming pools and hot tubs.

In addition, given the current state of the pandemic, when the pool and hot tub are open again to residents, it is important to have safeguards in place to maintain social distancing and proper sanitizing. As the orders imposing limited social and commercial interaction are relaxed, your Board of Directors needs to be concerned about imposing safe practices for use of the swimming pool and hot tub until there is no longer a need to do so as established by governmental and public health orders and reports. It is important to realize that in addition to having a duty to maintain the common areas in a reasonably safe condition, if there should be a claim that a resident contracted the COVID-19 virus due to negligent practices by the Association, the Association's liability insurance will likely not cover the claim. This is because most liability policies specifically exclude coverage for claims arising from communicable diseases.

In summary, until Governor Ducey issues an order expanding outdoor exercise activities to include swimming and use of a hot tub, your Association should not open these facilities. To prepare for opening, it would be prudent to form a Pool Committee to prepare procedures and rules for the use of these facilities when they can open to implement protective measures for residents.
